Terms and Conditions

Your entry into Natural Raw C's Win a Wellness Weekend in the Hunter Valley Competition (**the Competition**) is deemed acceptance of the following Terms and Conditions. Information on how to enter the Competition and the Prize(s) form part of these Terms and Conditions.

Who Can Enter

1. The Competition is open to Australian residents aged 18 years and over.
